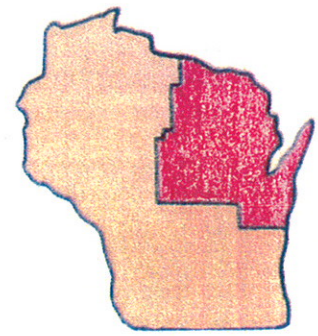

Leroy Stublaski, Wisconsin Department of commerce reported to the group that on September 01 2009 the Department has issued an emergency ruling regarding UDC energy calc's. This rule states that all submittals of plans not using perspective method for energy loss compliance must be submitted using the most current version of recheck available. This must be done via a downloaded version of the program rather than on line in order to assure that all the proper "Wisconsinisms" are addressed.
